

# Executive Summary – Joint Working Project Hypoglycaemia Assessment & Intervention for Positive Outcomes (HAIPO) Project 2021 - continuation of project. (Project ends 5 Sep 23)

## The organisations involved in this Joint Working Project:

The project will be led by a Steering Group, which will provide advice, support and overall direction for successful delivery of the project. The Steering Group will consist of representatives from:

- University Hospitals Plymouth NHS Trust
- South Western Ambulance NHS Foundation Trust
- Novo Nordisk Ltd
- Devon CCG

#### **Key objectives of the Joint Working Project:**

The project aims to proactively identify people living with diabetes and experiencing recurring episodes of hypoglycaemia, within the catchment area of University Hospitals Plymouth.

The objective is to conduct clinical review of these patients and optimisation of therapy to reduce the number of hypoglycaemia episodes and improve overall diabetes control. Use of appropriate interventions should result in improved quality of life and reduce longer term complications for people identified through the project.

The project aims to improve efficiency across the system through the creation of a new pathway and provision of an evidence-based model for potential adoption across the South West of England.

## **Expected outcomes and patient benefits of the Joint Working Project:**

## Expected benefits to people living with diabetes

- Reduction in hypoglycaemia events and/or severity of events
- Reduced impact on employment
- Improved quality of life

## **Expected benefits to the NHS**

- Efficiency gains across the local system
- Potential business case with outcomes to justify funding for system change

#### **Expected benefits to Novo Nordisk**

- Experience of Joint Working to support further collaboration opportunities
- Potential uplift in prescribing of some marketed products already listed on the Devon formulary, in accordance with local and national guidance and if deemed appropriate after clinical review by a patient's health care professional

#### **Measuring success of the Joint Working Project:**

A range of data will be analysed as part of the project, including audits of hypoglycaemia events and patient interventions as well as system costs. The Steering Group will conduct regular project reviews to assess progress against the stated aims and milestones.

#### **Timeframe of the Joint Working Project:**

The project will commence in September 2021 and run for two years until September 2023. The results will be published within 6 months of project completion (by 5<sup>th</sup> March 2024), and consideration will be given to earlier publication of any relevant interim findings.
